## Police Updates

Ranger Truck Sales - Councilman Fain made a motion to revoke Ranger Truck Sales business license per not doing stipulations to keep the business license. Motion seconded by Councilman Dodd. So Approved.

## Reports

Police - The Police report was presented for review. Total income for the month of February that stayed in the City was $\$ 8,906.63$.

Compactor - The Compactor report was presented for review. Total revenue for February was $\$ 305.25$. The City made a profit of $\$ 118.00$.

Library - The Library report was presented for review. 4 new patrons signed up in February; 75 visits to the library; The library made $\$ 5.60$.

## Items of Business

- Retirement Accounts for Employees

- Derelict and Blighted Property Ordinance

- Zoning/Building Codes

Councilman Holsomback made a motion to let this lay over until next month. Motion seconded by Councilman Dodd. So Approved.

## - Old City Hall Building

Bid 1 - Ricky L. Smith - 239 Deerfield Dr. NW, Sugar Valley, GA.
$\$ 18,604.00$ - New roof, siding on west and south side of building, 2 new windows, repair siding on north side of building, prime and paint.
The City only received one bid.
Councilman Fain made a motion to approve the bid from Ricky Smith to repair the outside of the old city hall building. Motion seconded by Councilman Holsomback. So Approved.

## - Garbage Collection

Councilman Holsomback made a motion to offer free trash pickup by Mauldin Trash to the citizens of Fairmount. Pick up to start in July with a 5-year contract. Cost to the City will be $\$ 8.65$ per customer per month with a 96 -gallon trash can, pick up will be on Wednesday's of each week. Motion seconded by Councilman Dodd. So Approved.

Councilman Fain made a motion to amend the agenda to discuss equipment. Motion seconded by Councilman Dodd. So Approved.
